CRIB CHECKLIST

- The consignment of cribs manufactured **on or after June 28, 2011 ARE accepted.**
- Cribs manufactured from **July 23, 2010 to June 28, 2011** may be consigned if the consignor provides a Certificate of Compliance from the crib manufacturer or retailer.
- Cribs manufactured **prior to July 23, 2010 will NOT be accepted under any circumstance.** Cribs that are unacceptable, for any reason, cannot be sold as toddler beds.

The reasons for this decision is based on the new regulations and laws set by the Consumer Products Safety Commission. <http://www.cpsc.gov/>

6. Do you have a copy of the manufacturer's instructions?	Yes – Continue	No – Obtain instructions if possible, continue
7. Does the crib have all of its original parts?	Yes – Continue	No – Obtain all parts or not able to consign
8. Do you know the history of the crib?	Yes – CONSIGN!!!	No – Not able to consign
